O R D E R

Learned counsel appearing for the State of Bihar submits, on instructions, that the appropriate authority of the State Government will display the list of eligible candidates in the NEET merit list on the official website of the Director of Medical Education, Patna, within twenty-four hours hence, so that the private medical colleges can admit students on the basis of the said list, if so advised. We accept this statement made by the learned counsel for the State. In the peculiar facts of the present case, we accede to the request of the State to extend the cut off date for completing the admission process by the private medical colleges within the State by 31st May, 2018.

However, we make it clear that no request for extension of cut off date at the instance of any party for whatsoever reason will be entertained.
