INTRODUCTION

Narayan Medical College & Hospital, Jamuhar, Sasaram was established by Deo Mangal Memorial Trust with the sole aim of imparting the clinical facilities to the needy, downtrodden, helpless and deprived people of the society by the qualified doctors of different specialties. Beside this it has also aim of imparting the good quality teaching and training to the young students admitted in this institution to become a responsible, sensible and kind hearted doctors, social workers, researchers and future teacher of medical colleges.

The institute is a residential campus with sufficient accommodation for the faculty members, staff and the students inside the campus. There are 2 hostels for undergraduate students (one for boys and one for girls) with a capacity to accommodate 750 students and 2 hostel for intern (one for boys and one for girls) and 2 hostel for PG students (one for boys and one for girls) at present. Hospital has 1100 Teaching beds. Beside this there is fully functional round the clock casualty and ICUs. All the 13 OTs are well equipped Dialysis, Plastic Surgery, Neuro argery, Urology, Gastroenterology Oncology and Cardiology units are well functional.

All the five lecture theaters are air conditioned and fully equipped with audiovisual aids. There is sprawling playground with all playing material. Gymnasium is available. 1. ELIGIBILITY FOR ADMISSION

A candidate must possess MBBS degree of a university recognized by M.C.I. & must have completed compulsory rotating Internship training of 12 months.

2. METHOD OF SELECTION

Selection will be made entirely on the basis of merit in the NEET PG-2022 and the choice of subject will be allocated on the basis of personal counseling by All India/State Counseling body or committee or institution authorised by Court of law or competent authority.

4. HOSTEL ACCOMMODATION

Postgraduate students will be provided accommodation in the PG hostel in the campus.

5. LEAVE

Only 20 days CL in a year. CL will not be carried forward in next year. Non other type of leave is permissible.

6. ASSESSMENT

Internal Assessment will be done at the end of each semester regarding competency, efficacy, clinical application & knowledge and for sent up for final University examination.

7. SUBMISSION OF PROTOCOL AND THESIS

Postgraduate students registered for MD/MS course shall be required to get his/her plan of thesis protocol (Synopsis) approved by his/her departmental Ethical committee & then Institutional ethical committee within 4 months of enrolment and submit it to Principal/ Student Section. The last date for submission of synopsis for the students registered for MD/MS degree will be 30th November of the admission year.

Post GraduateStudents have to present their thesis before Research Protocol Ethics Committee of Gopal Narayan Singh University prior to institution altaics committee .

8. OTHER TERMS & CONDITIONS

- a. Tenure of Postgraduate student will be 3 years as prescribed by Medical Council of India.
- b. Original certificates of the candidate who take admission will be retained in the Principal Office. The same will be returned to the candidate after completion of the course and deposition of tuition fee & other charges of all the three-years.
- c. All the candidates must bring the original certificates i.e. matriculation certificate, Caste certificate (if applicable), Permanent Medical Registration Certificate etc, to be MBBS mark sheets (each professional examinations), MBBS Degree certificate, Internship Completion Certificate, These original documents will be kept with the institute till his/her completion of the course.
- d. All the candidates who have been allotted seat during counseling and come for admission, shall be medically examined by a Medical Board constituted by the Institute. After depositing the requisite fees, they will join the course.
- e. After join the department all PG. students have to register themself to Bihar council of Medical Registration, Patna within two month.

9. IMPORTANT:

- a. Please note that the candidates who have mislead the institute or used unfair means to take admission or have provided false information/certificate or is found to have withheld or concealed some information his/her candidature/registration will be terminated with immediate effect and appropriate criminal/civil proceedings will be initiated against the candidate. The admission is provisionally granted to the candidates.
- b. It will be the responsibility of the candidate to ensure the correct address, mobile no. & email ID in the Admission office/Admission Register. The Institute shall not be responsible for any miscommunication or non-receipt for any communication. Change, if any, in this regard should be immediately intimated to this office.
- c. The decision of the Management/ Principal of the Institute shall be final in all the matters of student and no appeal will be entertained in this regard.
- d. Private practice in any form during the course is prohibited, if found, adequate penalty may be imposed by the Principal/Management. The period of training is strictly full time and continuous.
- e. Absence of more than 6 months will lead to cancellation of admission.
- f. Period of absence will lead to the extension of P.G. tenure without stipend
- g. The rules are subject to change in accordance with the decision of the institute taken from time to time. Any dispute in this regard to any matter referred to herein shall be subject to the jurisdiction of High Court of Patna only.

10. INSTITUTE LIBRARY

The Institute library is well stocked with all important text & reference medical books, Indian & Foreign Journals. Other facilities include photocopying, medlar, medline, video monitor facilities and modern learning resources materials (LRM). Books and periodicals are loaned to bonafide students for a specified period of time.

11. CODE OF CONDUCT FOR STUDENTS

Students have to maintain discipline in the college campus, failing which disciplinary action will be taken by the Management/Principal or such other persons specified on their behalf.

a) The following shall amount to acts of gross indiscipline:

- (i) Physical assault or threat to use physical force against any member of the teaching or nonteaching staff of any Department or any other persons within the Campus.
- (ii) Carrying or use or threat of use of any weapon.
- (iii) Carrying or use of prohibited substance such as, Gutkha, Pan, Cigarette, Ganja, Bhang or wine or variety of such things
- (iv) Violation of the status, dignity and honor of students belonging to other religion or Creating ill-will or intolerance on religious or communal grounds.
- (v) Any practice, whether verbal or otherwise, derogatory to Girls/ women.
- (vi) Any attempt at bribing or corruption in any manner.
- (vii) Willful destruction of institutional property or causing disruption in any manner of the functioning of the Institute.
- (viii) Any act that violate the rules and regulation of the Institute notified time to time.

b) **Ragging-** Regarding ragging, the directive of Supreme Court will be followed strictly. It is as under:- "As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside of the campus and the Institute authorities are determined not to allow any form of the ragging. Whoever directly or indirectly commits, participates in abets or instigates ragging within or outside any educational Institution, shall be suspended, expelled or rusticated from the Institution and shall also be liable to fine which may extend to Rs. 10,000/-. The punishment may also include cancellation of admission, suspension from attending the classes, withholding/withdrawing fellowship/ scholarship and other financial benefits, withholding or cancelling the result. The decision shall be taken by the Head of the Institution."

c) Prohibition of and Punishment for Ragging:

- (i) Ragging in any form is strictly prohibited, within the premises of College/Department of Institution and any part of it and outside the Campus.
- (ii) Any individual or collective act or practice or ragging constitute gross indiscipline shall be dealt with under this Rules.
- (iii) Ragging for the purposes of this rules, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are, in any way, considered junior or inferior by other students and includes individual or collective acts or practice which includes the following: Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student. The conduct includes but is not restricted to any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher; exploiting the services of a fresher, or any other students for completing the academic tasks assigned to an individual or a group of students; any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students; any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person; any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, "vicarious or sadistic thrill from activity or passively participating in the discomfiture to fresher or any other students; any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student. It also includes any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

- 1. No entry and exit from hostel after 8:00 PM for all the Girls students who go to library, otherwise the time will be 6 PM. Except those who are hospital duty.
- 2. Girls are instructed to be dressed in proper attire if they are outside their hostel room.
- 3. No electrical appliances like heater, AC, Iron, Immersion rod, induction coil etc. are permitted in the rooms except cooler.
- 4. The girls are expected to maintain decorum in the hostel. No loud noise, music or disturbances are permitted.
- 5. Any form of gathering must be pre approved by hostel warden/superintendant inside hostel premises. Any unauthorized gatherings or parties can lead to punishment for all attendees.
- 6. For any celebration in college canteen, prior permission by warden/superintendent is must celebration must be finished by 08:30 PM and all the girls must return in to hostel by 08:40 PM.
- 7. Surprise inspection can be done at any time by warden/Superitendent. The girls are expected to be present in their allotted rooms after 08:00 PM and before 08:00 AM in case of absent, proper explanation is required. If explanation is unsatisfactory then disciplinary action will be taken.
- 8. Hygiene and cleanliness of the hostel is responsibility of all inmates and everyone is expected to contribute towards it.
- 9. All queries regarding hostel will be entertained in the warden office between 6:00-6:30 PM everyday except Sunday & holiday. No queries will be attended in any case in the hospital/college/rooms except in emergency.
- 10.All leave must be pre-approved by principal after due recommended of warden/superintendent.
- 11.In case of emergency, girls may contact Principal/warden/Superintendent directly.

- 6. For any celebration in college canteen, prior permission by warden/superintendent is must celebration must be finished by 09:30 PM and all the Boys must return in to hostel by 09:40 PM.
- 7. Surprise inspection can be done at any time by warden/Superitendent. The Boys are expected to be present in their allotted rooms after 09:30 PM and before 08:00 AM in case of absent, proper explanation is required. If explanation is unsatisfactory then disciplinary action will be taken.
- 8. Hygiene and cleanliness of the hostel is responsibility of all inmates and everyone is expected to contribute towards it.
- 9. All queries regarding hostel will be entertained in the warden office located in Principal office in between 12:30 PM to 1"30 PM. No queries will be attended in the in any case in the hospital/college/rooms except in emergency.
- 10. All leave must be pre-approved by principal after due recommended of warden/superintendent.
- 11. In case of emergency, Boys may contact Principal/warden/Superintendent directly.
- 12. All Boys are instructed to have their meals in the dining hall. Nobody is allowed to take food to room. Any body found taking away food to their room will be doubly charged. Names of such students will be procured from mess manager.
- 13. Cooking in the room is strictly prohibits.
- 14. PG Students are strictly prohibited not to come back in the hostel in night if they have night duty. They should remain on duty place upto assigned time. They will not be all owed to enter in hostel in the night after 10:00 PM if they go for their night duty.
- 15. All the application for leave for leave must be submitted to Principal office after recommendation of warden/superintendent.
